Stimulant B – 3% acetic acid	Time and temperature : 10 days at 40°C
Stimulant D2 – All vegetable oils	Time and temperature : 10 days at 40°C

Overall migration is below 10 mg/dm² under standard testing conditions laid down in Regulation (EC) No. 10/2010. Traces of the following substances may be present in the final product.


